13. PLANNING APPLICATIONS.

A: Application:24/2023/0773 - Demolition of existing school building and development of land by the erection of 8 dwellings including the formation of a vehicular access and parking area, pedestrian accesses and pathways, landscaping and associated works at former Ysgol Rhewl , Rhewl. Members considered an email objection to the planning application from a local resident. After due consideration, the Members resolved to remain with the original observations of the Council not to object to the planning application due to the benefits that the additional housing would provide on the current redundant site.

B. Planning Application: 24/2024/1313/PF - Erection of a rural enterprise dwelling and associated works on land adjacent to Pen-y-Garth, Llanrhaeadr – no objections.

C. Planning Application: 24/2024/1155/PF - Erection of 2 holiday accommodation units, (Use Class C6) formation of parking and internal pathways, installation of package treatment plant and associated works at Golf Links farm, Rhewl – no objections.
