

MINUTES OF THE LLANYNYS COMMUNITY COUNCIL MEETING HELD ON TUESDAY 10<sup>TH</sup> SEPTEMBER 2024 IN THE PAVILION, RHEWL AT 7.45 P.M.

3. DECLARATIONS OF INTEREST.

4. DISCUSSION WITH THE MEMBERS OF THE PUBLIC IN ATTENDANCE.

5. CONFIRM THE MINUTES OF THE PREVIOUS COUNCIL MEETING.

6. MATTERS ARISING FROM THE MINUTES NOT APPEARING ON THE AGENDA.

A: Council still awaits Denbighshire County Council to repair the following highways within the community reported in the previous Council meeting:-

- 1: Highway between Erw Deg and Ffrith Farm in Llanrhaeadr.
2. Highway between Erw Deg via Fronheulog and Ty Mawr in Llanrhaeadr.
3. Minor road between the A525 via Bryn Caredig in Rhewl.

B. Denbighshire County Councillor Merfyn Parry has replaced both the Defibrillator pads and batteries purchased by the Community Council for both the Llanynys and Rhewl Defibrillators located within the former BT Kiosks' at both locations.
